

SPRING CREEK UTILITY DISTRICT
AMENDED NOTICE OF SPECIAL MEETING (JFAC)


Notice is hereby given to all interested members of the public that on **Tuesday, July 29, 2025 at 6:30 p.m.**, the Board of Directors ("Board") of the above captioned District will hold a *special* meeting, open to the public, at **25003 Pitkin Road, Suite D600, Spring, Texas 77386**, a designated meeting place of the District.

In addition, some Board members, consultants, and the public may participate by telephone/video conference per Texas Government Code Section 551.027 (****see below and the District's website www.springcreekud.org*). The Board may consider and authorize any action related to the following:

- 1) Public comments (*note: public comment policy in effect*);
- 2) Joint Facilities Advisory Committee ("JFAC") matters, including:
 - a) *Water*:
 - i) Water plant expansions status (MC89 WP No. 2; SCUD WP No. 3);
 - ii) SJRA water line extension/surface water supply status;
 - iii) Water reclamation/re-use (purple pipe) options;
 - iv) Drought conditions and well/supply issues (incl. DCP amendments, well data to LSGCD);
 - b) *Drainage*:
 - i) Stormwater Quality Management Program options;
 - c) *Other*:
 - i) Birnham Woods pedestrian bridge and sidewalk extension status;
 - ii) Budgets related to joint facilities;
 - iii) Regional agency coordination, election, and grant matters (incl. SJRA, LSGCD, Region 6 Flood Planning Group, HGAC, MCDD6, etc.);
 - iv) 2025 Legislative matters;
 - d) *Next joint meeting date (tent. March 30 or 31, 2026)*;
- 3) Additional District engineering/construction/maintenance project matters and related consultant updates;
- 4) *Executive Session pursuant to Texas Government Code, Section 551.071, 551.074, et. seq.;
- 5) Reconvening in open session and authorize any action resulting from executive session;
- 6) Discuss pending business/future agendas (Aug. 18 – Board Mtg.; Oct. 7 – NNO).
